SCRUTINIZER'S REPORT

The Chairman, Amines & Plasticizers Limited D Building, Shiv Sagar Estate, Dr. Annie Besant Road, Worli, Mumbai – 400 018

Dear Sir,

With reference to your letter 16th July, 2014 appointing me as a Scrutinizer for the purpose of ascertaining the result of Resolutions sought to be passed by means of Postal Ballot pursuant to the provisions of section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 (including any statutory modifications of re-enactment thereof for the time being in force.

1. I submit my report as under:

- 1.1 The company has completed on 26th July, 2014 the dispatch of postal ballots along with postage pre-paid business reply envelopes to its Members whose name(s) appeared on the Register of Members/list of beneficiaries as on 18th July, 2014.
- 1.2 The shareholders of the Company had option to vote on the Resolutions either through the postal ballot forms physically or through the e-voting facility. Shareholders opting for e-voting facility to cast their votes on the designated website https://www.evotingindia.com/ of Central Depositary Services (India) Limited (CDSL).
- 1.3 Particulars of all the Postal Ballots Forms received in physical or through evoting process from the members have been consolidated and entered in a sheet separately maintained for the purpose.
- 1.4 The postal ballots were kept under safe custody before commencing the scrutiny of such postal ballots.
- 1.5 The postal ballot box was opened on 26th August, 2014 in my presence.

- 1.6 The postal ballot forms were duly opened in my presence and scrutinized and the shareholdings were matched/ confirmed with the Register of Members of the Company as on 18th July, 2014.
- 1.7 All postal ballot forms received either in physical or by casting of votes electronically through CDSL portal upto the close of working hours (6.00 PM) on 25th August, 2014, being the last date and time fixed by the company for receipt of the ballot forms, were considered for scrutiny.
- 1.8 Envelopes containing postal ballot forms dispatched to 3696 Shareholders
- 1.9 Envelopes containing postal ballot forms returned undelivered aggregated to 692. These envelopes were not opened and kept separately.
- 1.10 a. Envelopes containing postal ballot forms received after 25th August, 2014 were not considered. These envelopes were not opened and kept separately and treated as if the reply from such shareholder(s) has not been received as per the instructions No. 7 in the postal ballot form.
 - b. I did not find any defaced or mutilated postal ballot form.
