

With reference to your letter 29th December, 2014 appointing me as a Scrutinizer for the purpose of ascertaining the result of Resolutions sought to be passed by means of Postal Ballot pursuant to the provisions of section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 (including any statutory modifications of re-enactment thereof for the time being in force).

- 1. I submit my report as under:
