Chidambaram blames NDA's 'excessive taxes' for runaway fuel prices

New Delhi: Former finance minister P Chidambaram on Tuesday blamed "excessive taxes" on petrol and diesel for runaway fuel prices. "Relentless rise in prices of petrol and diesel is not inevitable because the price is built up by excessive taxes on petrol and diesel. If taxes are cut, prices will decline significantly," Chidambaram tweeted as the rupee shrank further to 71.54 against the dollar to push up fuel prices to new highs.

Petrol price in Delhi rose to a record Rs 79.31 a litre and diesel climbed to an all-time high of Rs 74.34, stoking public anger and sparking fresh demand for excise duty cut to cushion the spike. Petrol price has risen by Rs 2.17 per litre since August 16, while diesel has climbed by Rs 2.62, the highest in any fortnight since June last year when state-owned fuel retailers began revising prices daily.

Sonia-led NAC was 'supporting ground for Naxals', says BJP

New Delhi: Calling Congress "synonymous with confusion and conspiracy", BJP on Tuesday claimed the party had compromised national security for political opportunism as the erstwhile Sonia Gandhi-headed National Advisory Council was "supporting ground for Naxals" during the UPA regime and some party leaders "romanticised Naxalism".

"Congress tried to mainstream Maoism and Naxalism during its rule and the party should therefore call itself the Congress Party of Maoists or the Indian National Congress (Maoists)," BJP spokesperson Samhit Patra said at a press conference. He showed a letter which he said was written by one "comrade" to another and it talked about Congress willing

to fund their activities and contacting its leader Digvijay Singh for assistance. "National security is an issue of paramount importance and to play with national security for political opportunism is something which Congress has been doing," the BJP leader said.

He claimed the letter was written by "Comrade Surendra to Comrade Prakash on September 25 last year and it said Congress leaders were willing to assist and fund the process".

He alleged the letter contained a phone number of Digvijay Singh, who he said was Congress president "Rahul Gandhi's guru". Patra alleged the Congress had always been double-faced on Naxalism, as some opposed it while others within

the party romanticised Naxalism. "The National Advisory Council, the coterie of those who were closest to the then Congress president Sonia Gandhi, was the supporting ground for Naxalites," he said.

He claimed that Congress leader Jairam Ramesh had written to the Maharashtra government to release Mahesh Raut, an activist who was arrested for his Naxal links.

Accusing Congress of having "so much love for convicted Naxals", Patra alleged the party compromised national security for way too long.

Asked about Digvijay Singh during the government to arrest him, Patra said, "Singh should be in a hurry or should he panic. The law will take its course."

India reminds US of 'strategic relations' amid sanction threat

Oil Imports From Iran, S-400 Deal With Russia May Figure In Talks

New Delhi: Ahead of the maiden 2+2 dialogue, India on Tuesday called upon the US to keep in mind the significance of Indo-US strategic relations before nursing any thought of imposing sanctions on the Indian government for its decision to purchase S-400 anti-aircraft missile defence system from Russia.

While underlining the importance of the dialogue, which will see secretary of state Mike Pompeo and secretary of defence Jim Mattis engaging with foreign minister Sushant Swaraj and defence minister Nirmala Sitharaman on Thursday, the government also said there was no question of acting under any compulsion from the US on the issue of energy imports from Iran.

"We hope US will not forget the strategic relations it enjoys (with India and other countries). US has to take a call and exercise that waiver (from sanctions) based on America's interests of its relationship with each country," official sources here said.

India has decided to go ahead with the S-400 purchase despite pressure from the US to shun the deal. A senior US defence official had recently said that it may not be possible for the US to completely insulate India from any Countering America's Adversaries Through Sanctions Act (CAATSA) fallout if India went ahead with the deal

as they described the 2+2 talks as one of the most important diplomatic events in India this year. The much delayed dialogue is finally taking place at a time when India is grappling with the threat of US sanctions for its oil imports from Iran and the finalisation of \$6 billion S-400 missile-defence system deal with Russia. Both issues are likely to figure prominently in the talks.

India has decided to go ahead with the S-400 purchase despite pressure from the US to shun the deal. A senior US defence official had recently said that it may not be possible for the US to completely insulate India from any Countering America's Adversaries Through Sanctions Act (CAATSA) fallout if In-

dia went ahead with the deal. In the run up to the September 6 talks, India has also made three important points before the Trump administration on its oil imports from Iran which sources here described as "main kind of relationship in the region".

First, India meets almost 83% of its energy requirements from external sources. Twenty-five per cent of this comes in the form of crude from Iran. Second, India has asked US to suggest alternative sources of crude available including the pricing involved.

"Third, we have also made the point that some of our refineries are dependent on certain kind of crude oil. However, there is no question of taking any decision on the issue of oil imports under compulsion from either the US or Iran," said a source.

Official sources said that while India did not want to see Iran as a nuclear-weapon state, it respected Iran's rights to peaceful uses of nuclear energy. India's position is in line with the 2015 UNSC resolution 2231 which calls for full and timely implementation of Joint Comprehensive Plan of Action (JCPOA) concluded the same year by China, France, Germany, Russia, UK, US, EU and Iran.

On whether or not Communications, Compatibility and Security Agreement (COMCASA) will be signed after the talks on Thursday, sources said both sides will take stock of the "enabling instrument". In case the agreement, which will help India obtain encrypted and secure communication technology from the US, isn't signed during the visit, the two countries can still be expected to announce support for the agreement "in principle".

Govt tells Russia to tie up with OFB to make AK-103 rifles in India

New Delhi: The government has advised Russia that its firm Kalashnikov Concern should tie up with state-run Ordnance Factory Board (OFB) if it wants its proposal to manufacture the AK-103 assault rifles in India to be considered by the defence ministry.

This comes after the MoD shot down Kalashnikov Concern's proposal for a joint venture with the Adani Group, which has recently entered the defence sector, to produce the 7.62x39 mm calibre AK-103 gun, which are a derivative of the iconic AK-47 rifle.

"If Russia wants a government-to-government deal, it cannot suggest private sector companies for joint ventures," said a source.

Cong condemns arrest of girl in TN who called BJP 'fascist'

New Delhi: Amid uproar over the arrest of a girl for calling BJP "fascist" in Tamil Nadu, Congress said the police action proves that there is "undeclared emergency" in the country with no respect for individual rights, adding the 2019 battle will be between "fascism represented by BJP" and "democracy represented by progressive forces".

AICC spokesman Manish Tewari said, "If this is not undeclared emergency, then how else would you characterise this situation? What happened on a flight in Tamil Nadu was not only an assault on our fundamental rights, it was an assault on the Constitution and democracy. It was an assault on the idea of India. It was fascism playing itself out in its fullest glory!"

MP CM asks Cong to expel Digvijaya for Maoist links

Bhopal: The "urban Maoist" controversy has heightened political tension in poll-bound Madhya Pradesh, with chief minister Shivraj Singh Chouhan urging the Congress party on Tuesday to expel Digvijaya Singh for "Maoist connections", and Digvijaya hitting back by daring the government to arrest him.

Retweeting social media posts on Digvijaya's contact number being found in a letter seized from one of the "urban Maoists", Shivraj Singh Chouhan said: "Reports of senior Congress leader Digvijaya Singh's nexus with Maoists is a matter of concern. Earlier, too, he had made irresponsible statements on the matter and there were allegations of anti-national activities against him. Congress should immediately take action and sack him from the party."

"The real face of Congress party and its leaders has been exposed. Nexus with those trying to divide the country! What could be more shameful? Betraying motherland to help one family retain power. India will not tolerate this," he tweeted.

Digvijaya Singh responded with equal aggression, saying, "If I have such connections, then the government should arrest me now. I challenge the Union and state governments that if I am involved, they should start the arrest proceedings immediately."

After the allegations, speaking to reporters in Satna, Digvijaya remarked: "First, the chief minister called me a 'deshdrohi', and now this."
